GENERAL GUIDELINES

- 1. This book of "General Conditions of Contract" is applicable to both types of tenders i.e. "Percentage rate tenders and Item rate tenders". Accordingly, alternative provisions for conditions Nos. 4, 10 & 12 of the General Rules and Directions are given in this book. The appropriate alternatives will be applicable in specific cases depending on whether this is used for percentage rate tender (KINFRA-7)or item rate tender (KINFRA-8). "General Conditions of Contract" shall be available in downloadable manner from website "www.kinfra.org"
- 2. KINFRA-6 abridged from KINFRA-7/8, Schedules A to F, special conditions/specifications and drawings will be issued to intending tenderers only. The standard form will not be issued along with the Tender Documents but the same shall form part of the agreement to be drawn and signed by both parties after acceptance of tender. The standard form shall be available in downloadable manner from website "www.kinfra.org"
- 3. The intending bidders will quote their rates in Schedule A ie. Schedule of Quantities.
- 4. The proforma for registers and Schedules A to F are only for information and guidance. These are not to be filled in the Standard Form. The Schedules with all blanks, duly filled, shall be separately issued to all intending tenderers. For filling and returning in the manner prescribed.

- 1. Contractors who fulfil the following requirements shall be eligible to apply.
 - (a) Should have satisfactorily completed the works as mentioned below during the last **Seven years** ending last day of the month previous to the one in which tenders are invited.
 - Three similar works each costing not less than Rs.21.77 Lakhs, or two similar works each costing not less than Rs.32.66 Lakhs, or one similar work costing not less than Rs.43.54Lakhs
 - ii) The bidder should be the original equipment manufacturer or its authorised agent/distributor, approved by Central Pollution Control Board (CPCB)
 - iii) The bidders capable of supplying processer/ sensors /instruments/ analysers/ equipment with certification of Institutions like USEPA, MCERTS, UBA, TUV etc. as approved by CPCB will only be participated.
 - iv) The bidder should have installed their servers at CPCB or at Cloud, software evaluation mechanism of protocol integration etc and capability to transmit Real Time Data from Effluent monitoring system to Central Pollution Control Board (CPCB) on behalf of the Company.

(Similar work shall mean work for online monitoring systems of Effluent Treatment Plant)



The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for bids.

- **2.** The intending bidder must read the terms and conditions of **KINFRA-6** carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- 3. Information and Instructions for bidders shall form of bid document.
- **4.** All bids shall be submitted manually in the relevant envelope(s)/ cover(s), as per the type of tender. The signed copies of documentary evidences as the proof of eligibility criteria shall be submitted to KINFRA in hard copies also.
- **5.** The bidder is advised to submit the bids well before the stipulated date & time to avoid any kind of network issues, traffic congestion, etc. In this regard, KINFRA shall not be responsible for any kind of such issues faced by bidder.
- **6. Earnest Money Deposit (EMD):** The bidder has to submit an amount of **Rs.50,000**/- as DD from a Scheduled/Nationalized bank in favour of Managing Director, KINFRA Trivandrum, payable at Trivandrum. EMD of the unsuccessful tenders will be refunded without any interest on finalisation of the contract with the successful bidder.EMD will be refunded to the Contractor after remittance of performance guarantee and execution of the agreement.
- **7. Tender Fee:** The bidder has to submit a **non-refundable** amount of **Rs.2,950/**-(inclusive of 18% GST) towards cost of tender document, in the form of DD from a Scheduled/Nationalized bank in favour of Managing Director, KINFRA Trivandrum, payable at Trivandrum.

Cover-2 to be addressed and super scribed 'PART-2 Price Bid' and the name of the work, name and address of the bidder and to contain the priced schedule alone duly filled in, in the manner specified and signed on all pages.

The bidders, who submit their bids for this tender, accept that they have clearly understood and agreed the terms and conditions including the Form/Annexures of this tender. Mention of price details at any place other than the designated place, shall disqualify the bid and the bid shall be summarily rejected.

- 11. The Technical bid shall be opened first on due date and time as mentioned above. The time and date of opening of financial bid of contractors qualifying the technical bid shall be communicated to them at a later date.
- 12. If the bid is made by an individual, it shall be signed with full name and complete address. If it is made by a partnership firm, it shall be signed with the co-partnership name by a member of the firm who shall sign his own name and give the name and address of each of the other partners of the firm and attach a copy of "Power of Attorney" with the bid authorising him to sign on behalf of the other partners. If the tender is made by a Private Company / Public Company, it shall be signed by a person on behalf of the company having necessary authorisation or Power of Attorney to do so. The bidder shall fix his / her full signature duly stamped on each page of this tender and on any additional information provided as part of the bid.
