The appropriate alternatives will be applicable in specific cases depending on whether this is used for percentage rate tender (KINFRA-7)or item rate tender (KINFRA- 8). “General Conditions of Contract” shall be available in downloadable manner from website “[www.kinfra.org](http://www.kinfra.org)”
2. KINFRA-6 abridged from KINFRA-7/8, Schedules A to F, special conditions/specifications and drawings will be issued to intending tenderers only. The standard form will not be issued along with the Tender Documents but the same shall form part of the agreement to be drawn and signed by both parties after acceptance of tender. The standard form shall be available in downloadable manner from website “[www.kinfra.org](http://www.kinfra.org)”
3. The intending bidders will quote their rates in Schedule A ie. Schedule of Quantities.
4. The proforma for registers and Schedules A to F are only for information and guidance. These are not to be filled in the Standard Form. 1. Contractors who fulfil the following requirements shall be eligible to apply.

### Eligibility criteria

- a) Contractors with A class registration in Central/State Govt departments/PSUs.
- b) Bidder should have satisfactorily completed the works as mentioned below during the last seven years ending last day of the month previous to the one in which tenders are invited.

Three similar works each costing not less than **Rs.712.46 Lakhs** or two similar works each costing not less than **Rs.1068.70 Lakhs** or one similar work costing not less than **Rs.1424.93 Lakhs**

And

One work of any nature (either part of (i) above or a separate one) costing not less than **Rs.712.46 Lakhs** with some Central/State Government Department, Central / State Autonomous Body, Central/State Public Sector Undertaking.

And

The bidder Should have undertaken, executed and commissioned on their own at least one contract for supplying and laying 500 mm diameter and above DI pipe lines for a length of at least 2 km under one contract and satisfactorily completed and commissioned the same within the last seven years ending last day of the month previous to the one in which tenders are invited.

*(Similar work shall means supplying and laying of DI pipe lines)*

*The value of executed works shall be brought to current costing level by enhancing actual value of work at simple rate 7% per annum; calculated from the date of completion to last date of receipt of applications for bids.*

- c) Should have a solvency certificate from any bank to an amount of **Rs. 712.46 Lakhs** (Scanned copy of original solvency to be uploaded)
  - d) Should not have incurred any loss in more than two years during the last five years ending 31<sup>st</sup> March 2020.
  - e) Should have average annual financial turnover of Rs.1781.16 lakhs on construction works during the last three consecutive financial years ending 31<sup>st</sup> March 2020 (2017-18, 2018-19, 2019-20).
2. **Bid submitted without undertaking from manufacturer of pipes, as specified in page 29 of this NIT are liable to be rejected outright.**
  3. The intending bidder must read the terms and conditions of KINFRA-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
  4. Information and Instructions for bidders posted on website shall form part of bid document.
  5. The tender document(s), may be downloaded free of cost from the e-Government Procurement (e-GP) website ([www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in)). No payment is required for downloading the tender documents from the above website however a bid submission fee, as mentioned below in this document, is required to be remitted through online payment mechanism for e-procurement system of Govt. of Kerala. Only those bidders having a valid and active registration, on the date of bid submission, shall submit bids online on the e-GP website.
  6. All bids shall be submitted online on the e-GP website only in the relevant envelope(s)/ cover(s), as per the type of tender. No manual submission of bids shall be entertained for the tenders published through e-GP system under any circumstances.
  7. The e-GP system shall not allow submission of bids online after the stipulated date & time. The bidder is advised to submit the bids well before the stipulated date & time to avoid any kind of network issues, traffic congestion, etc. In this regard, KINFRA shall not be responsible for any kind of such issues faced by bidder.

8. Ineligible bidders or bidders who do not possess valid & active registration, on the date of bid submission, are strictly advised to refrain themselves from participating in this tender. If such instances are noticed, the same shall be treated as “fake bidding” by the respective bidder and such bidder shall be blacklisted as per KINFRA rules in force. ## GUIDELINES FOR E-PROCUREMENT

Prospective bidders willing to participate in this tender shall necessarily register themselves with e-procurement portal ([www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in)). The tender timeline is available in the critical date section of this tender published in [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in).

### A). Online Bidder registration process:

Bidders should have a Class II or above Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on [www.cca.gov.in](http://www.cca.gov.in). Once, the DSC is obtained, bidders have to register on [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in) website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost.

### B). Online Tender Process:

### C). Tender Document Fees and Earnest Money Deposit (EMD)
