- ii) The average annual turnover of the bidder should not be less than Rs.130.66 lakhs during the three preceding financial years(2011-2012,2012-13 & 2013-14)

- iii) The bidder should possess the latest valid Solvency Certificate from a Nationalized / Scheduled bank for an amount not less than Rs.34.84 lakhs.
- iv) The bidder should not have incurred any loss in the last three financial years.
- v) The bidder should be a well-established and reputed HVAC Contractor having minimum three years experience in HVAC works\*.
- vi) The bidder should have full-fledged service facility in south India.
- vii) Joint ventures and consortiums formed for the purpose of bidding are not eligible to quote for the tender.
