"We have already finalised the project report and submitted it to the Government", said Sri. S. Ramnath, MD-KINFRA. "IDZ project is set for

IDZs will be developed around major seaports and airports, and KINFRA plans to acquire 3,000 acres in 10 years, including 500 acres in two years, said Dr. C Jayasankar Prasad, Special Officer-KINFRA IDZ

Of the total project cost of Rs 1,466.92 cr., Rs 690.05 cr. will be the cost for land acquisition, Rs 664.62 cr. for development, including infrastructure cost, and Rs 112.25 cr. for interest levied during construction and financing charges, he said.

Target industries identified in IDZs include food and mostly manufacturing, including electronics, and agro-based units, engineering, IT and IT-enabled services, textiles, gems and jewellery.

"Without bypassing the LAR Act we are looking for other possibilities for state support to acquire land to develop an IDZ, if the land is least inhabited and if the
