- The intending bidder must read the terms and conditions of KINESCO-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Information and Instructions for bidders posted on website shall form part of bid document.
- The tender document(s), may be downloaded free of cost from the e-Government Procurement (e-GP) website (www.etenders.kerala.gov.in). No payment is required for downloading the tender documents from the above website however a bid submission fee, as mentioned below in this document, is required to be remitted through online payment mechanism for e-procurement system of Govt. of Kerala. Only those bidders having a valid and active registration, on the date of bid submission, shall submit bids online on the e-GP website.
- All bids shall be submitted online on the e-GP website only in the relevant envelope(s)/ cover(s), as per the type of tender. No manual submission of bids shall be entertained for the tenders published through e-GP system under any circumstances. However signed copies of documentary evidences as the proof of eligibility criteria shall be submitted to KINESCO in hard copies also.
- The e-GP system shall not allow submission of bids online after the stipulated date & time. The bidder is advised to submit the bids well before the stipulated date & time to avoid any kind of network issues, traffic congestion, etc. In this regard, KINESCO shall not be responsible for any kind of such issues faced by bidder.
- Ineligible bidders or bidders who do not possess valid & active registration, on the date of bid submission, are strictly advised to refrain themselves from participating in this tender. If such instances are noticed, the same shall be treated as “fake bidding” by the respective bidder and such bidder shall be blacklisted as per KINESCO rules in force. The bidders, who submit their bids for this tender after digitally signing using

their Digital Signature Certificate (DSC), accept that they have clearly understood and agreed the terms and conditions including the Form/ Annexures of this tender. Mention of price details at any place other than the designated place, shall disqualify the bid and the bid shall be summarily rejected.

- 1.1.1 Registration of contractors should be valid on the last date of submission of bids. In case the last date of submission of bid is extended, the registration of contractor should be valid on the original date of submission of bids.
- 1.1.2 Intending bidders is eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below:

Qualification of Bidders:

Contractors who fulfil the following requirements shall be eligible to apply.

- a) Should have satisfactorily completed the works as mentioned below during the last **Seven years ending previous day of last date of submission of bids.**
- Contractor should possess a valid A grade license issued by the Kerala State Electricity Licensing Board with a minimum of 7 years experience in Operation and Maintenance service contract of electrical distribution system including EHT substation.
 - The bidder should have in his custody the appropriate personnel as listed in the relevant form, for employment in the KINESCO licensee areas.
 - The bidder, on their own as prime contractor, should have satisfactorily completed at least **one similar work** of Operation and Maintenance service contract of electrical distribution system including EHT substations and downstream electrics with value of similar work not less than **Rs. 48.57 lakhs / year** within the last seven years in a single contract as prime contractor.

OR

The bidder, on their own as prime contractor, should have satisfactorily completed at least **two similar works** of Operation and Maintenance service contract of electrical distribution system including EHT substations and downstream electrics with value of each similar work in a single contract not less than **Rs. 36.42 lakhs / year** within the last Seven years as prime contractor.

OR

The bidder, on their own as prime contractor, should have satisfactorily completed at least **three similar works** of Operation and Maintenance service contract of electrical distribution system including EHT substations and downstream electrics with value of each similar work in a single contract not less than **Rs. 24.28 lakhs / year** within the last Seven years as prime contractor.

- The average annual turnover of the bidder in the preceding three financial years as on the date of bid opening shall not be less than rupees one crore.

A certificate to this effect shall be produced by the bidder from an officer of the rank not below the rank of Executive Engineer in the Government or PSUs/ Chief Project Manager or equivalent in other organisations.

2. Agreement shall be drawn with the successful bidders on prescribed Format which is available www.kinfra.org. Bidders shall quote their rates as per various terms and conditions of the said form which will form part of the agreement.
- 3 The time allowed for carrying out the O&M will necessarily be **12 Months** from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, as mentioned by KINESCO in Additional Conditions (Refer Contract Period).
- 4 The site for the work is the electrical licensee areas of KINESCO at Kakkanad, Kalamaserry and Palakkad.
- 5 The bid document consisting the schedule of manpower of various categories that will be required for the O&M works and the set of terms and conditions of the contract to be complied with and other necessary drawings and documents except Standard General Conditions of Contract Form can be seen on website www.etenders.kerala.in. General Conditions of Contract (KINESCO- 7/8) shall be available in downloadable manner from www.kinfra.org and shall form part of bid document.
- 6 Tender documents and tender schedule may be downloaded free of cost from the e-GP Web site www.etenders.kerala.go.in . Tender fee of **Rs 2500 + VAT @5%** shall be remitted through **online payment mechanism for e-procurement system of Govt. of Kerala.**

- 7 Pre Bid Meeting shall be held in the **KINESCO Office @ Common Facility Centre, KEPIP, Kakkanad. Pin: 682042 Tel: 04842415222** at **10:30 AM** on **05/06/2017** to clear the doubt of intending bidders, if any.
- 8 The bid submitted shall be opened at **10:00 am** on **16/06/2017**.
- 9 Earnest Money Deposit (EMD) amounting to **Rs.50,000/-** (Rupees Fifty Thousand only) to be remitted online through e-GP site by the bidder.
- 10
- a) **Performance Guarantee**, the amount collected at the time of executing contract agreement, will be 5% of the Annual Contract Value (agreed PAC) and the deposit will be retained till the end of Contract Period. At least 50% of this deposit shall be collected in the form of Treasury Fixed Deposit and the rest in the form of Bank Guarantee. The validity of BG and treasury deposit shall be up to end of contract period plus 3 months.
- b) **Additional Performance Guarantee** will be applicable as per Govt orders wherever required.

11 The bid submitted is treated as invalid if:

- a) *The bidder is found ineligible*
- b) *The bidder does not upload all the documents as stipulated in the bid document. However if he has submitted hard copies of all the required certificates, duly signed in a sealed cover, before the appointed date and time of opening of bid, his bid will be considered.*
- c) *Any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted by the bidder in the office of bid opening authority.*

- 12 The description of the work is as follows:** The work necessarily includes operation and maintenance of 110 kV substation and distribution system in the licensee areas of KINESCO at Kakkanad, Operation and maintenance of 11 kV substation and Distribution systems in the licensee areas of KINESCO at Kalamassery and Operation and maintenance of 22 kV substation and Distribution systems. The scope covers all the preventive, routine, breakdown maintenance activities of all the substations and associated plant and machinery and the HT and LT distribution networks. The contractor is also reasonable for attending complaints from KINESCO's consumers, establishing new metered service connections to the consumers as instructed by the KINESCO office. Maintaining and up keeping of necessary records, submission of reports to the engineer in charge on a daily basis, etc. The scope of the work also covers establishing 24 hours reliability of the power distribution systems of KINESCO and any other operation and maintenance work required to be performed for the

proper functioning of the substation and distribution. Intending Bidders are advised to inspect and examine the site and shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidder shall be responsible for arranging and maintaining at his own cost all tools & plants facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of local conditions and other factors having a bearing on the execution of the work.

- 13 The CEO, KINESCO does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidder shall be summarily rejected.
- 14 Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection.
- 15 The CEO, KINESCO reserves to himself the right of accepting the whole or any part of the bid and the bidder shall be bound to perform the same at the rate quoted.
- 16 The contractor shall not be permitted to bid for works if he/she is the near relative of an officer of KINESCO posted as Project Officer or Finance Officer.
- 17 No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of Kerala is allowed to work as a contractor for a period of one year after his retirement from Government service, without the prior permission of the Government of Kerala in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of Kerala as aforesaid before submission of the bid or engagement in the contractor's service.
- 18 ***The bid for the O&M shall remain valid for a period of 90 days from the date of opening of technical bid.*** If any bidder withdraws his bid before the said period or issue of work order, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to KINESCO, then KINESCO shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the bidder shall not be allowed to participate in the rebidding process of the work.

- 19 This notice inviting Bid shall form a part of the contract document. The successful bidders/contractor, on acceptance of his bid by the Accepting Authority shall within 15 days from the stipulated date of start of the work, sign the contract consisting of:-
- a) The Notice Inviting Bid, all the documents including additional conditions, specifications and drawings, if any, forming part of the bid as uploaded at the time of invitation of bid and the rates quoted online at the time of submission of bid and acceptance thereof together with any correspondence leading thereto.
 - b) Standard KINESCO Form 7/8 or other standard KINESCO Form as applicable
- 20 This notice inviting Bid shall form a part of the contract document. The successful bidders/contractor, on acceptance of his bid by the Accepting Authority shall within 15 days from the stipulated date of start of the work, sign the contract
- 21 The orders or circulars issued on technical and financial matters by the Government shall stand automatically incorporated in the tender document issued subsequent to such circulars/orders.
- 22 Rate Quoted by the bidder shall be monthly rate (for 1 month)**

23 Payment Terms

The contractor on the expiry of each month of the AMC period, to submit the monthly bills which will be verified with the attendance sheets by the KINESCO officials. The payment will be monthly, the monthly proportional cost of the annual quoted amount with deductions if any based on the attendance sheet of the staff and all prevailing taxes except service tax. Service tax will be paid additionally as per relevant clause in this tender document

GENERAL GUIDELINES FOR E-PROCUREMENT

Prospective bidders willing to participate in this tender shall necessarily register themselves with e-procurement portal (www.etenders.kerala.gov.in). The tender timeline is available in the critical date section of this tender published in www.etenders.kerala.gov.in.

A). Online Bidder registration process:

Bidders should have a Class II or above Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on www.cca.gov.in. Once, the DSC is obtained, bidders have to register on www.etenders.kerala.gov.in website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost.

B). Online Tender Process:

The tender process shall consist of the following stages:

- i. **Downloading of tender document:** Tender document will be available for free download on www.etenders.kerala.gov.in. However, tender document fees shall be payable at the time of bid submission as stipulated in this tender document.
- ii. **Pre-bid meeting:** Mentioned in KINESCO 6
- iii. **Publishing of Corrigendum:** All corrigenda shall be published on www.etenders.kerala.gov.in and shall not be available elsewhere.
- iv. **Bid submission:** Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document on www.etenders.kerala.gov.in. No manual submission of bid is allowed and manual bids shall not be accepted under any circumstances.
- v. **Opening of Technical Bid and Financial Bid:** The technical bid will be opened at the same time mentioned in Information & instruction to the bidders. All documents in support of technical qualifications shall be submitted (online). Failure to submit the documents online will attract disqualification. Only the Price bid of qualified bidders will be opened on a pre-intimated date after the scrutiny of their submitted documents

C). Tender Document Fees and Earnest Money Deposit (EMD)

The Bidder shall pay, a tender document fees and Earnest Money Deposit. The Bid security is required to protect the purchaser against risk of Bidder's conduct, which would warrant the forfeiture of security.

Online Payment modes: The tender document fees and EMD can be paid in the following manner through e-Payment facility provided by the e-Procurement system:

- i. **State Bank of Travancore (SBT) Internet Banking:** If a bidder has a SBT internet banking account, then, during the online bid submission process, bidder shall select SBT option and then select Internet banking option. The e-Procurement system will re-direct the bidder to SBT's internet banking page where he can enter his internet banking credentials and transfer the tender document and EMD amount.
- ii. **National Electronic Fund Transfer (NEFT)/ Real Time Gross Settlement (RTGS):** If a bidder holds bank account in a different bank, then, during the online bid submission process, bidder shall select NEFT / RTGS option. An online remittance form would be generated, which the bidder can use for transferring amount through NEFT / RTGS either by using internet banking of his bank or visiting nearest branch of his bank. After obtaining the successful transaction receipt no., the bidder has to update the same in e-Procurement system for completing the process of bid submission. Bidder should only use the details given in the Remittance form for making a NEFT / RTGS payment otherwise payment would result in failure in e-Procurement system.

As NEFT payment status confirmation is not received by e-Procurement system on a real-time basis, bidders are advised to exercise NEFT mode of payment option at least 48 hours prior to the last date and time of bid submission to avoid any payment issues.

For RTGS the timings that the banks follow may vary depending on the customer timings of the bank branches and settlement from RBI. Bidders are advised to exercise RTGS mode of payment at least 24 hours prior to the last date and time of bid submission to avoid any payment issues.

NEFT / RTGS payment should be done according to following guidelines:

- i. **Single transaction for remitting Tender document fee and EMD:** Bidder should ensure that tender document fees and EMD are remitted as one single transaction.
- ii. **Account number as per Remittance Form only:** Account no. entered during NEFT/RTGS remittance at any bank counter or during adding beneficiary account in Internet banking site should be the same as it appears in the remittance form generated for that particular bid by the e-Procurement system. Bidder should ensure that tender document fees and EMD are remitted only to the account number given in the Remittance form provided by e-Procurement system for that particular tender.

Bidders must ensure that the banker inputs the Account Number (which is case sensitive) as displayed in the Remittance form. No additional information like bidder name, company name, etc. should be entered in the account no. column along with account no. for NEFT / RTGS remittance.

- iii. **Only NEFT / RTGS Remittance Allowed:** Account to Account transfers, State Bank

Group Transfers (GRPT), Payments from NRE Accounts, SWIFT Transfers, IMPS or Cash payments are not allowed and are treated as invalid mode of payments. Bidder must ensure that the banker does NEFT or RTGS (for above 2 lakhs payments as per RBI guidelines) transaction only and specially instruct the banks not to convert the payment type to GRPT or any other payment mode.

- iv. **Amount as per Remittance form:** Bidder should ensure that the amount being remitted is neither less nor higher than the amount shown in remittance form.
- v. **UTR Number:** Bidders should ensure that the remittance confirmation (UTR number) received after NEFT / RTGS transfer should be updated as it is, in the e-Procurement system for tracking the payment.
- vi. **One Remittance Form per Bidder and per Bid:** The remittance form provided by e-Procurement system shall be valid for that particular bidder and bid and should not be re-used for any other tender or bid or by any other bidder.

Any transaction charges levied while using any of the above modes of online payment has be borne by the bidder. The supplier/contractor's bid will be evaluated only if payment status against bidder is showing "Success" during bid opening.

D). SUBMISSION PROCESS:

For submission of bids, all interested bidders have to register online as explained above in this document. After registration, bidders shall submit their Technical bid and Financial bid online on www.etenders.kerala.gov.in along with online payment of tender document fees and EMD.

For page by page instructions on bid submission process, please visit www.etenders.kerala.gov.in and click "Bidders Manual Kit" link on the home page.

It is necessary to click on "Freeze bid" link/ icon to complete the process of bid submission otherwise the bid will not get submitted online and the same shall not be available for viewing/ opening during bid opening process.
