- 1. This book of "General Conditions of Contract" is applicable to both types of tenders i.e.," Percentage rate tenders and Item rate tenders". Accordingly, alternative provisions for conditions of the General Rules and Directions are given in this book. The appropriate alternatives will be applicable in specific cases depending on whether this is used for percentage rate tender (KINFRA-7) or item rate tender (KINFRA-8). "General Conditions of Contract" shall be available in downloadable manner from website "www.kinfra.org"
- 2. KINFRA-6 abridged from KINFRA-7/8, Schedules A to F, special conditions/specifications and drawings will be issued to intending tenderers only. The standard form will not be issued along with the Tender Documents but the same shall form part of the agreement to be drawn and signed by both parties after acceptance of tender. The standard form shall be available in downloadable manner from website "www.kinfra.org"
- 3. The intending tenderers will quote their rates in Schedule A i.e. Schedule of Quantities.
- 4. The Performa for registers and Schedules A to F are only for information and guidance. These are not to be filled in the Standard Form. The Schedules with all blanks shall be separately issued to all intending tenderers for filling and returning in the manner prescribed. - 2. Information and Instructions for tenderers posted on website shall form part of tender document.
- 3. The tender document(s), may be downloaded free of cost from the e-Government Procurement (e-GP) website (www.etenders.kerala.gov.in). No payment is required for downloading the tender documents from the above website however a tender submission fee, as mentioned below in this document, is required to be remitted through online payment mechanism for e-procurement system of Govt. of Kerala. Only those tenderers having a valid and active registration, on the date of tender submission, shall submit tenders online on the e-GP website.
- 4. All bids shall be submitted online on the e-GP website only in the relevant envelope(s)/ cover(s), as per the type of tender. No manual submission of tenders shall be entertained for the tenders published through e-GP system under any circumstances.
- 5. The e-GP system shall not allow submission of tenders online after the stipulated date & time. The tenderer is advised to submit the tenders well before the stipulated date

& time to avoid any kind of network issues, traffic congestion, etc. In this regard, KINFRA shall not be responsible for any kind of such issues faced by tenderer.

- 6. Ineligible tenderers or tenderers who do not possess valid & active registration, on the date of tender submission, are strictly advised to refrain themselves from participating in this tender. If such instances are noticed, the same shall be treated as "fake bidding" by the respective tenderer and such tenderer shall be blacklisted as per KINFRA rules in force. The tenderers, who submit their tenders for this tender after digitally signing using their Digital Signature Certificate (DSC), accept that they have clearly understood and agreed the terms and conditions including the Form/ Annexures of this tender. Mention of price details at any place other than the designated place, shall disqualify the tender and the tender shall be summarily rejected.

- 1. Registration of original equipment manufacturers (OEM)/suppliers/tenderers should be valid on the last date of submission of tenders. In case the last date of submission of tender is extended, the registration of supplier should be valid on the original date of submission of tenders.
- 2. Intending tenderers are eligible to submit the tender provided, the tenderer has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works.
- **3.** The e-GP system shall not allow submission of tenders online after the stipulated date & time. The tenderer is advised to submit the tenders well before the stipulated date & time to avoid any kind of network issues, traffic congestion etc. In this regard, KINFRA shall not be responsible for any kind of such issues faced by tenderer.

### 4. Eligibility Criteria:

OEM/suppliers/tenderers who fulfil the following requirements shall be eligible to apply.

Before participating in the tender, the intending bidders are advised to satisfy themselves whether the equipment offered are fully met with the guaranteed technical specifications mentioned in the tender. The tender documents of those companies / firms who fail in the PQ process would be rejected summarily and no correspondence or intimation would be given to such companies or firm and the decision of KINFRA in this regard is final.

- a) The bidder should be the original equipment manufacturer of Ektron, Prescott, Alpha Technologies, MonTech or its authorized Indian Dealer/agent/Supplier.
- b) *The tender shall be accompanied by Copy of* Manufacturers Authorization Form obtained from the original equipment manufacturer, if the bidder is not an original equipment manufacturer.
- c) The bidder should have successfully completed supply, installation and commissioning of MDR in any NABL accredited laboratory. The tender shall be accompanied by the copy of successfully completed installation certificate from NABL accredited laboratory.
- 5. The tenderers who have earlier failed to execute the purchase order(s) and/or blacklisted by KINFRA / Rubber Board/Central or State Govt organizations shall not be eligible to participate in this tender.
- 6. A declaration must be given to the effect that the tenderer has not been debarred from tendering by any authority.

"I/we hereby declare that I/we have not been Blacklisted, debarred/suspended by any Central/State Govt Depts/ Central/State Govt PSUs, Autonomous and statutory bodies under State/ Central."

- **7.** KINFRA reserves the right to waive minor deviation, if they do not materially affect the capacity of the tenderer to perform the contract.
- 8. The successful bidder shall execute the agreement with MD, Rubber Park India (P) Ltd., Valayanchirangara after remitting the security deposit as per the details specified in the purchase order. The bills are to be raised in the name of Rubber Park India (P) Ltd. (RPIPL), and the payment will be released by KINFRA/RPIPL.

## GENERAL GUIDELINES FOR E-PROCUREMENT

Prospective tenderers willing to participate in this tender shall necessarily register themselves with e-procurement portal (<u>www.etenders.kerala.gov.in</u>). The tender timeline is available in the critical date section of this tender published in <u>www.etenders.kerala.gov.in</u>.

### A). Online Tenderer registration process:

Tenderers should have a Class II or above Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on <u>www.cca.gov.in</u>. Once, the DSC is obtained, tenderers have to register on <u>www.etenders.kerala.gov.in</u> website for participating in this tender. Website registration is a one-time process without any registration fees. However, tenderers have to procure DSC at their own cost.

#### B). Online Tender Process:

The tender process shall consist of the following stages:

- i. **Downloading of tender document:** Tender document will be available for free download on <u>www.etenders.kerala.gov.in</u>. However, tender document fees shall be payable at the time of tender submission as stipulated in this tender document.
- ii. Pre-bid meeting: As per NIT
- iii. **Publishing of Corrigendum:** All corrigenda shall be published on <u>www.etenders.kerala.gov.in</u> and shall not be available elsewhere.
- iv. **Tender submission**: Tenderers have to submit their tenders along with supporting documents to support their eligibility, as required in this tender document on <u>www.etenders.kerala.gov.in</u>. No manual submission of tender is allowed and manual tenders shall not be accepted under any circumstances.
- v. **Opening of Technical Bid and Financial Bid:** The technical bid will be opened at the same time mentioned in Information & instruction to the tenderers. All documents in support of technical qualifications shall be submitted (online). Failure to submit the documents online will attract disqualification. Only the Price bid of qualified tenderers will be opened on a pre-intimated date after the scrutiny of their submitted documents

## C). Tender Document Fees and Earnest Money Deposit (EMD)

The Tenderer shall pay, a tender document fees and Earnest Money Deposit. The Bid security is required to protect the purchaser against risk of Tenderer's conduct, which would warrant the forfeiture of security.

**Online Payment modes:** The tender document fees and EMD can be paid in the following manner through e-Payment facility provided by the e-Procurement system:

- i. <u>State Bank of India (SBI) Internet Banking</u>: If a tenderer has a SBI internet banking account, then, during the online tender submission process, tenderer shall select SBI option and then select Internet banking option. The e-Procurement system will redirect the tenderer to SBI's internet banking page where he can enter his internet banking credentials and transfer the tender document and EMD amount.
- ii. <u>National Electronic Fund Transfer (NEFT)</u>/ <u>Real Time Gross Settlement (RTGS):</u> If a tenderer holds bank account in a different bank, then, during the online tender submission process, tenderer shall select NEFT / RTGS option. An online remittance form would be generated, which the tenderer can use for transferring amount through NEFT / RTGS either by using internet banking of tenderer's bank or visiting nearest branch of his / her bank. After obtaining the successful transaction receipt no., the tenderer has to update the same in e-Procurement system for completing the process of tender submission. Tenderer should only use the details given in the Remittance form for making a NEFT / RTGS payment otherwise payment would result in failure in e-Procurement system.</u>

As NEFT payment status confirmation is not received by e-Procurement system on a real-time basis, tenderers are advised to exercise NEFT mode of payment option at least 48 hours prior to the last date and time of tender submission to avoid any payment issues.

For RTGS the timings that the banks follow may vary depending on the customer timings of the bank branches and settlement from RBI. Tenderers are advised to exercise RTGS mode of payment at least 24 hours prior to the last date and time of tender submission to avoid any payment issues.

NEFT / RTGS payment should done according to following guidelines:

- i. <u>Single transaction for remitting Tender document fee and EMD</u>: Tenderer should ensure that tender document fees and EMD are remitted as one single transaction.
- ii. <u>Account number as per Remittance Form only</u>: Account no. entered during NEFT/RTGS remittance at any bank counter or during adding beneficiary account in Internet banking site should be the same as it appears in the remittance form generated for that particular tender by the e-Procurement system. Tenderer should ensure that tender document fees and EMD are remitted only to the account number given in the Remittance form provided by e-Procurement system for that particular tender.

Tenderers must ensure that the banker inputs the Account Number (which is case sensitive) as displayed in the Remittance form. No additional information like tenderer name, company name, etc. should be entered in the account no. column along with account no. for NEFT / RTGS remittance.

iii. <u>Only NEFT / RTGS Remittance Allowed</u>: Account to Account transfers, State Bank Group Transfers (GRPT), Payments from NRE Accounts, SWIFT Transfers, IMPS or Cash payments are not allowed and are treated as invalid mode of payments. Tenderer must ensure that the banker does NEFT or RTGS (for above 2 lakhs payments as per RBI guidelines) transaction only and specially instruct the banks not to convert the payment type to GRPT or any other payment mode.

- iv. <u>Amount as per Remittance form</u>: Tenderer should ensure that the amount being remitted is neither less nor higher than the amount shown in remittance form.
- v. <u>UTR Number</u>: Tenderers should ensure that the remittance confirmation (UTR number) received after NEFT / RTGS transfer should be updated as it is, in the e-Procurement system for tracking the payment.
- vi. <u>One Remittance Form per Tenderer and per Tender:</u> The remittance form provided by e-Procurement system shall be valid for that particular tenderer and tender and should not be re-used for any other tender or by any other tenderer.

Any transaction charges levied while using any of the above modes of online payment has be borne by the tenderer. The supplier/contractor's tender will be evaluated only if payment status against tenderer is showing "Success" during tender opening.

#### D). SUBMISSION PROCESS:

For submission of tenders, all interested tenderers have to register online as explained above in this document. After registration, tenderers shall submit their Technical bid and financial bid online on <u>www.etenders.kerala.gov.in</u> along with online payment of tender document fees and EMD.
