- 2. KINFRA-6 abridged from KINFRA-7/8, Schedules A to F, special conditions/specifications and drawings will be issued to intending tenderers only. The standard form will not be issued along with the Tender Documents but the same shall form part of the agreement to be drawn and signed by both parties after acceptance of tender. The standard form shall be available in downloadable manner from website "www.kinfra.org"
- 3. The intending bidders will quote their rates in Schedule A ie. Schedule of Quantities.
- 4. The proforma for registers and Schedules A to F are only for information and guidance. These are not to be filled in the Standard Form. ## 1. Eligibility Criteria:

Contractors who fulfil the following requirements shall be eligible to apply.

- a. Bidder should have **KPWD A** class or equivalent registration in central/state Govt. departments/PSUs
- b. Bidder should have GST registration.
- c. Bidder should have satisfactorily completed the works as mentioned below duringlast **seven** years.
  - Three similar works costing not less than the amount equal to Rs.1.96 crores OR
  - > Two similar works costing not less than amount equal to **Rs.2.93 crores.**

OR

> One similar works costing not less than **Rs. 3.91 crores**.



(The definition of similar work shall mean Design, Construction, Supply, Installation, Testing and Commissioning of sewage Treatment Plant. The bidder should have satisfactorily designed, constructed, supplied, installed and commissioned at least one Sewage Treatment Plant of 150 KLD Capacity during the last seven years, ending last day of the month previous to the one in which tenders are invited. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for bids).

- d. Should have solvency certificate from bank amount а any to an 1.96 equivalent to crores (Scanned of original solvency сору certificate to be uploaded)
  - 2. The bidder shall submit the Preliminary Design (Key Design) based on the Biological Treatment using modified MBR (Membrane Bio Reactor) Process and must meet the minimum criteria asper the specifications provided.
  - 3. Joint Venture or consortium constituted for participating in this tender alone is not permitted.
  - 4. The bidder shall submit the Payment Conditions in the prescribed format -given in clause No. 19 (Additional Condition of Tender Document). This should be submitted in the letter head of the contractor duly signed and sealed.
  - **5.** The intending bidder must read the terms and conditions of KINFRA-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of allthe documents required.

  - **9.** The e-GP system shall not allow submission of bids online after the stipulated date & time. The bidder is advised to submit the bids well before the stipulated date & time to avoid any kind of network issues, traffic congestion, etc. In this regard, KINFRA shall not be responsible for any kind of such issues faced by bidder.

10. Ineligible bidders or bidders who do not possess valid & active registration, on the



date of bid submission, are strictly advised to refrain themselves from participating inthis tender. If such instances are noticed, the same shall be treated as "fake bidding"by the respective bidder and such bidder shall be blacklisted as per KINFRA rules in force. ## **GUIDELINES FOR E-PROCUREMENT**

Prospective bidders willing to participate in this tender shall necessarily register themselves with e-procurement portal (<u>www.etenders.kerala.gov.in</u>). The tender timeline is available in the critical date section of this tender published in <u>www.etenders.kerala.gov.in</u>.

# A). Online Bidder registration process:

Bidders should have a Class II or above Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on <u>www.cca.gov.in</u>. Once, the DSC is obtained, bidders have to register on <u>www.etenders.kerala.gov.in</u> website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost.

## B). Online Tender Process:

# C). Tender Document Fees and Earnest Money Deposit (EMD)
